Additional Details

This year's conference will include a tour of the Strategic Alliance for FLEX Emergency Response (SAFER) facility. The nuclear industry has two National Response Centers, one in Memphis, TN, and one in Phoenix, AZ. These response centers help U.S. nuclear power plants meet the requirements of the NRC's Mitigation Strategies Order, which was issued after the Fukushima accident. The centers contain extra equipment to duplicate plants' emergency diesel generators, pumps, hoses, etc. This equipment would maintain plant safety functions for an indefinite period if an event disabled a plant's installed safety systems.
